COURSE PRESENTATION



As part of the diagnostic tests useful in the definition of rheumatic diseases, the microscopic examination of biopsies, collected from various organs and various tissues involved during these systemic diseases, may play an essential role. Some of these biopsy procedures are minimal-invasive and they can be also performed by the rheumatologists after adequate preparation. The direct management of the biopsy procedures by the rheumatologist may increase the availability of this diagnostic procedure, making it the fastest execution. It can also improve the diagnostic value by eliminating intermediaries between rheumatologist and pathologist, by eliminating defects caused by incorrect methods of sampling and by improper handling and/or storage of the biopsy. It should not be underestimated the chance to gain access more easily to biopsy tissue in scientific research. The course targets mainly to specialists rheumatologists who want to acquire the technical capacity to properly implement some fundamental biopsies (synovial membrane, skin and subcutaneous tissue, skeletal muscle, salivary glands, blood vessels). The course will focus primarily on biopsy procedures, and its proper requests, in order to implement the various techniques, particularly in relation to the preparation of the patient, the implementation of the biopsy procedure and handling and/or storage of the samples to be sent to the pathologist.

The course will therefore have three main purposes:

- 1 to define the exact role of biopsy procedures useful in the histopathologic diagnosis of rheumatic diseases (indications, appropriateness of requests, contraindications). In particular, the diagnostic guidelines of the main clinical manifestations suggestive of a rheumatic disease must be defined with reference to the role that histological definition of the disease process can play.
- 2 -Practical training to acquire the skills needed to perform both appropriateness and safety, biopsy procedures on the various structures of the musculoskeletal system (muscle, synovium), skin and minor salivary glands.
- 3 -Improve knowledge on the histopathological features of the most important localizations in the course of rheumatic diseases
